Deuel County Commissioner Meeting

October 3, 2023

The Deuel County Commissioners met on the above date with the following officials present: Commissioner Jean Timm, Commissioner William Klingman, County Attorney Jonathon Stellar, Sheriff's office administrator Leslie Snell, Sheriff Deputy Jim McCormick, Roads Superintendent Kelly Kopetzky, and Clerk Tammy Sherman. Others present; Jim & Jane Starostka, Don Wilson. The meeting, notice of which was published in the Chappell Register according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. Motion by Commission Timm, seconded by Commissioner Klingman excused absence for Commissioner Fischer. Timm, aye, Klingman, aye, Fischer absent. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Timm; Fischer, absent, Klingman, aye, Timm, aye. The minutes of the September 19, 2023, meeting was approved upon motion of Commissioner Klingman, second Commissioner Timm; Fischer, absent, Timm, aye, Klingman, aye.

Public comment: none.

Board of Equalization: none.

Ron Leal, Region 21 Emergency Management director was unable to attend the meeting. He submitted upcoming training information, prior to the meeting that was reviewed by the Commissioners.

Jim and Jane Starostka were on hand for continued discussion on the work needed on Rd 165 (Wheatland). The county is continuing to patch the road and will continue to grade the dam on a regular basis. Ideas for funding were discussed. Until the County Highway Superintendent position is filled, the Rd 165 project is on hold. The county will investigate some of the ideas discussed and report at the next meeting.

RESOLUTION 2023-21: DEUEL COUNTY BUDGET DOCUMENT RESOLUTION AUTHORIZING THE COUNTY TREASURER TO TRANSFER FUNDS. WHEREAS, the Deuel County Commissioners have the authority to request the Officials of the County to perform statutory duties, ALSO WHEREAS, the Deuel County Commissioners have the power to establish a budget to be used by the various Officials/offices to conduct County business. Within this budget, the transfer is adopted to correct clerical errors to ensure funds are reported correctly. THEREFORE, the Deuel County Commissioners authorize County Treasurer Alicia Adams to make a transfer from the 0995 COUNTY VISITORS IMPROVEMENT FUND to the 0990 COUNTY VISITORS PROMOTION FUND not to exceed the amount of \$13,928.00 to correct clerical errors done by the County Clerk. Resolution 2023-21 is correcting Resolution 2023-4 which requested the transfer out of and into the accounts in reverse order. Motion by Commissioner Klingman, seconded by Commissioner Timm to approve Resolution 2023-21 as presented. Timm, aye, Fischer, absent, Klingman, aye.

RESOLUTION 2023-22: DEUEL COUNTY BUDGET DOCUMENT RESOLUTION AUTHORIZING THE COUNTY TREASURER TO TRANSFER FUNDS; WHEREAS, the Deuel County Commissioners have the authority to request the Officials of the County to perform statutory duties, ALSO WHEREAS, the Deuel County Commissioners have the power to establish a budget to be used by the various Officials/offices to conduct County business. Within this budget, the transfer is adopted to correct clerical errors to ensure funds are reported correctly. THEREFORE, the Deuel County County GENERAL FUND to the 1000 COUNTY FAIR FUND not to exceed the amount of \$1785.00 to correct clerical errors done by the County Clerk. The Clerk mistakenly added \$1,785.00 back to the General Fund for voided check #20230217 when the funds should have been added back into the Fair Fund. Motion by Commissioner Timm, seconded by Commissioner Klingman to approve Resolution 2023-22 as presented. Fischer, absent, Klingman, aye, Timm, aye.

The Safety committee meeting was held.

Operations of the highway department were discussed. Roads Supt. Kopetzky stated that the preschool asked for a loader bucketful of gravel. One application has been received for the Road Labor position. Kopetzky will contact the applicant to offer employment. The county will continue to advertise for a Highway Superintendent. The county will investigate the state requirements for a county highway superintendent for the possibility to promote within the department.

McCormick and Snell reported for the Sheriff's department. A discussion was held concerning the truck parking at the Big Springs I-80 interchange. Advertising will continue for a deputy position.

Auditor Don Wilson addressed the board concerning the July 2022 through June 2023 audit. Wilson reviewed the correct procedure for making and recording motions. Wilson mentioned the Budget for 2024-2025; the county may want to use the general fund to pay for emergency communication expenses. Wilson will not be renewing his contact with the county. The Board expressed their appreciation for Wilson's service over the years.

A report on fees collected in the amount of \$16,233.84 for the month of September 2023 was presented by the County Court's office. The report was reviewed and accepted for filing.

A report on fees collected in the amount of \$1,161.98 for the month of September 2023 was presented by the County Clerk's office. The report was reviewed and accepted for filing.

Warrants in the amount of \$117,990.57 were approved upon motion of Commissioner Klingman, second of Commissioner Timm, (Payroll \$33,510.38 Claims \$84,480.19); Fischer, absent, Timm, aye, Klingman, aye.
