Deuel County Commissioner Meeting

October 17, 2023

The Deuel County Commissioners met on the above date with the following officials present: Commissioner Steve Fischer, Commissioner Jean Timm, Commissioner William Klingman, County Attorney Jonathon Stellar, County Treasurer Alicia Adams, Assessor Michele Bartlett, Sheriff's office administrator Leslie Snell, Sheriff Deputy Jim McCormick, Veterans Service Officer Patrica Nelson, Roads Superintendent Kelly Kopetzky, and Clerk Tammy Sherman. Others present, Candace Meredith. The meeting, notice of which was published in the Chappell Register according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Timm; Fischer, aye, Klingman, aye, Timm, aye. The minutes of the October 3,2023, meeting was approved upon motion of Commissioner Timm, second Commissioner Klingman; Fischer, abstain, Timm, aye, Klingman, aye.

Public comment: Veterans Officer Patrica Nelson updated the Commissioners on the happenings with Veterans Service Office.

Board of Equalization: At 8:35 a.m. a motion by Commissioner Fischer, seconded by Commissioner Klingman to enter into the Board of Equalization, for Resolution 2023-23, Setting Levies in and for Deuel County and a Homestead correction; Fisher, aye, Timm, aye, Klingman, aye.

No discussion was held concerning Road 165. Item tabled until the next meeting.

Candace Meredith with the Nebraska Association of County Officials updated the Commissioners on the happenings with the Association. The annual convention is coming up in December. The new office in Ogallala is under construction. She advised the Board on Cyber Security funding and a Bridge match program. The Board appreciated the information and the work the association is doing on behalf of Nebraska counties.

Assessor Barlett presented the following building permits for final approval as recommended by the Planning & Zoning Board: 2023-02 – platform enclosure; 2023-03 – pole building; 2023-04 – pole building; 2023-05 – pole building. Motion by Commissioner Klingman, seconded by Commissioner Fischer to approve the recommendation to approve the above noted building permits. Timm, aye, Fischer, aye, Klingman, aye. Assessor Bartlett referenced building permit 2023-01. The plan for the new tower has been changed. The board directed her to request an addendum to the permit, which will be reviewed for approval by the Planning & Zoning Board.

Assessor Bartlett, the Planning & Zoning Administrator, updated the Board on a new meeting site and current members for the Planning & Zoning Board. They will be meeting at the Fire Hall in Big Springs with notice posted according to statute. A motion by Commissioner Fischer, seconded by Commissioner Klingman to compensate Assessor Bartlett \$400 a month for her time as administrator of the Planning & Zoning regulations/board until the end of the 2023-2024 budget year. Bartlett assumed the responsibility of Planning & Zoning Administrator on September 19, 2023.

A motion by Commissioner Klingman, seconded by Commissioner Timm to authorize Chairman Fischer to sign the Management Representation letter from Auditor Don Wilson. Timm, aye, Klingman, aye, Fischer, aye.

Operations of the highway department were discussed. The county will continue to advertise for a Highway Superintendent. The county will investigate the state requirements for a county highway superintendent for the possibility to promote within the department. A motion by Commissioner Timm, seconded by Commissioner Klingman to appoint Anthony J. Krajewski as an employee of Deuel County serving as Highway Superintendent, effective October 17, 2023, until such time as a permanent replacement can be hired. Fischer, aye, Klingman, aye, Timm, aye. A short discussion was held concerning paying the highway department hourly in lieu of salary. Sherman will contact the auditor concerning the regulations regarding wage payment methods. Item tabled until next meeting.

McCormick and Snell reported for the Sheriff's department.
