December 5, 2023

The meeting, notice of which was published in the Chappell Register according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. Motion by Commissioner Fischer, seconded by Commissioner Klingman; excused absence for Commissioner Timm. Fischer, aye, Klingman, aye, Timm, absent. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Fischer; Fischer, aye, Klingman, aye, Timm, absent. Operations of the highway department were discussed. Roads Superintendent Kelly Kopetzky reported that he will publish a request for bids on the old grader in the paper. The Roads department payroll will remain salary after additional investigation.

Sheriff Scott DeCoste and Sheriff's office administrator Leslie Snell reported for the Sheriff's department.
