Deuel County Commissioner Meeting

February 20, 2024

The Deuel County Commissioners met on the above date with the following officials present: Commissioner Steve Fischer, Commissioner William Klingman, Commissioner Jean Timm, County Attorney Jonathon Stellar, County Treasurer Alicia Adams, County Assessor Michele Bartlett, Sheriff Scott DeCoste, Sheriff's office administrator Leslie Snell, Highway Superintendent Anthony Krajewski, Roads Superintendent Kelly Kopetzky, and Clerk Tammy Sherman. Others present; Jane & Jim Starostka, William Franken, Mike Ward, Peggy Hayden, Barney Steger. The meeting, notice of which was published in the Chappell Register according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Timm; Fischer, aye, Klingman, aye, Timm, aye. The minutes of the February 6, 2024, meeting was approved upon motion of Commissioner Klingman; Fischer, aye, Timm, aye.

Public comment: none.

No business for the Board of Equalization.

The annual report for Deuel County from Sarah Paisley, UNL 4-H Educator from Garden County was tabled until the next meeting.

A motion was made by Commissioner Fischer, seconded by Commissioner Klingman to approve the Interlocal agreement with UNL for extension services. Timm, aye, Klingman, aye, Fischer, aye.

A brief discussion was held concerning the rifle range located at the Deuel County Fair Grounds. A motion was made by Commissioner Fischer, seconded by Commissioner Klingman to recess the meeting @8:40 a.m. for a trip out to the rifle range. Timm, aye, Klingman, aye, Fischer, aye. Those choosing to travel to the rifle range included Fischer, Timm, Klingman, Stellar, DeCoste, Kopetzky, Bartlett, Sherman, Starostka, Franken, Steger, Hayden, Krajewski, and Ward. The meeting was reconvened at 9:12 a.m. at the courthouse. The rifle range will be built up at the main shooting backstop with the sides extended into a horseshoe shape. Stellar will get Kopetzky a summary of rifle range specifications. The goal is to have the changes done by spring. A rifle range committee will be appointed composed of local citizens to monitor the rifle range.

Resolution 2024-3; DEUEL COUNTY BUDGET DOCUMENT; RESOLUTION AUTHORIZING THE COUNTY TREASURER TO TRANSFER FUNDS. WHEREAS, The Deuel County Commissioners have the authority to request the Officials of the County to perform statutory duties. ALSO, WHEREAS, the Deuel County Commissioners have the power to establish a budget to be used by the various Officials/offices to conduct County business. Within this budget, transfers may be adopted to ensure no negative fund balances will occur. THEREFORE, the Deuel County Commissioners authorize County Treasurer Alicia Adams to make a transfer from the County General to the 911 Fund not to exceed the amount of \$15,000.00. A motion was made by Commissioner Timm, seconded by Commissioner Klingman to approve the resolution as read. Fischer, aye, Klingman, aye, Timm, aye.

Operations of the highway department were discussed. Hwy Superintendent Krajewski updated the Commissioners on the progress of the One & Six Report. The hearing will be April 2, 2024, during the regular Commissioners meeting. Krajewski will put together an estimate to rebuild the dam on Wheatland Road. He explained that he has been looking for grant funds to help repair Wheatland Road and Road 165/Road 167 south of town but has not been able to find any programs Deuel County qualifies for. Roads Superintendent Kelly Kopetzky reported the warranty cost for the new 911 generators is \$650 each for a five-year agreement. It was agreed that the warranty should be purchased.

Sheriff Scott DeCoste reported for the Sheriff's department. The department is waiting for bids on a replacement vehicle.

A motion by Commissioner Fischer, seconded by Commissioner Klingman to enter executive session for a personnel issue at 9:45 a.m. with the following present: Fischer, Timm, Klingman, Stellar, Adams and Sherman. A motion at 10:17 a.m. by Commissioner Fischer, seconded by Commissioner Klingman to adjourn from executive session with no action taken. Fischer, aye, Timm, aye, Klingman, aye.
