## Deuel County Commissioner Meeting March 5, 2024

The Deuel County Commissioners met on the above date with the following present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jean Timm, County Attorney Jon Stellar, County Treasurer Alicia Adams, County Assessor Michele Bartlett, Sheriff's office administrator Leslie Snell, Sheriff Scott DeCoste, Deputy Sean Holloway, Roads Superintendent Kelly Kopetsky, Highway Superintendent Tony Krajewski, Jerry Radke, Matt Adams, Christy Warner and Clerk Tammy Sherman. The meeting, notice of which was published in the Chappell Register according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Timm; Fischer, aye, Klingman, aye, Timm, aye. The minutes of the February 20, 2024, meeting was approved upon motion of Commissioner Timm, second Commissioner Fischer. Fischer, aye, Timm, aye, Klingman, aye.

Public comment. Jerry Radke expressed his appreciation of the road conditions in his area.

The Deuel County Court fee report for February was presented for review and filing. The fee totals \$31,647.00. The Deuel County Clerk's office monthly report for February was presented for review and filing. The fee totals \$1,930.94.

A motion by Commissioner Fischer seconded by Commissioner Klingman to enter the Board Equalization at 8:35 a.m. Fischer aye, Klingman aye, Timm aye.

Christy Warner, Director of Kimball County Transit, updated the Board on the services they provide. KCT provided 4089 rides for residents of Deuel County. The rides were provided for work, shopping, medical, family visits, airport, etc. KCT employs five people from the area at the Chappell location. They will be expanding the service to include transportation to WNCC, for Veterans to Cheyenne Veterans Medical facility and work shifts for Clean Harbor. Wagner expressed that even with the expansion local service will be a priority. The Commissioners extended their appreciation of the service being provided for Deuel County and the importance of the service to the area.

Sarah Paisley, UNL 4-H Educator of Garden County presented the annual update for Deuel County. Interviews are scheduled for the 4-H Educator position for Deuel County. Paisley notified the Board the Majorie Radke will resign her position as 4-H Aide/Office Manager effective April 30, 2024. A motion by Commissioner Klingman, seconded by Commissioner Fischer to accept Radke's resignation with regret. Timm, aye, Klingman, aye, Fischer, aye.

Matt Adams, with the Deuel County Shooters 4-H group addressed the Commissioners concerning approval to apply for grants for a building with restroom facilities at the trap range. The building will be especially useful during tournaments. Motion by Commissioner Fischer, seconded by Commissioner Timm to give approval for Adams to apply for grants and hold fund raisers on behalf of the Deuel County Shooters 4-H group for a small building. Timm, aye, Klingman, aye, Fischer, aye. Adams will contact the Weed Superintendent Cris Burks to spray ground bare in the trap range area.

A discussion was held concerning the rifle range. With the recommendation of the County Attorney Stellar, the rifle range will be temporarily closed until specific rifle range regulations can be implemented. A motion by Commissioner Klingman, seconded by Commissioner Timm to form a Rifle Range Committee consisting of four residents, Sheriff DeCoste and County Attorney Jon Stellar. Fischer, aye, Timm, aye, Klingman, aye. The Clerk's office will help organize the committee.

Deuel County Treasurer Alicia Adams presented the Tax Sale Report.

A brief discussion concerning the entrances to the courthouse.

The safety committee for the courthouse met at 9:32 a.m.

At 9:48 a.m. the Commissioners suspended the meeting for a short break. At 9:52 a.m. the Commissioners resumed the meeting.

Stellar and Sherman presented a proposal for options to include family health coverage that could be offered to the county employees. After a brief discussion, Sherman and Stellar will gather additional information to present at the next meeting.

Highway Superintendent Krajewski updated the Board on the operations in the roads department. Krajewski will start gathering bids for work on the dam on Wheatland Road. He suggested paying for all the materials to do the work and hiring a roads contractor to complete the work. Krajewski hoped he could have cost figures to review at the next meeting. He recommended repairing Wheatland Road and Road 167 in sections. The Commissioners expressed their appreciation of the recommendation and will consider this as a plan to move forward. The One- & Six-Year Road Plan hearing is scheduled for the April 2<sup>nd</sup> Commissioners meeting.

Sheriff Deputy Holloway reported for the Sheriff's office.

A motion by Commissioner Timm, seconded by Commissioner Klingman to enter executive session at 10:18 a.m. with the following present: Fischer, Klingman, Timm, Sherman. At 10:29a.m. a motion was made by Commissioner Fischer, seconded by Commissioner Timm to adjourn the executive session. Timm, aye, Klingman, aye, Fischer, aye.
