## Deuel County Commissioner Meeting March 19, 2024

The Deuel County Commissioners met on the above date with the following present: Chairperson Steve Fischer, Commissioner William Klingman, Commissioner Jean Timm, County Attorney Jon Stellar, County Assessor Michele Bartlett, Sheriff's office administrator Leslie Snell, Sheriff Scott DeCoste, Deputy Sean Holloway, Deputy Jim McCormick, Roads Superintendent Kelly Kopetsky, Highway Superintendent Tony Krajewski, Peggy Hayden, Kristian Fusilier, and Clerk Tammy Sherman. The meeting, notice of which was published in the Chappell Register according to law, was called to order with the Pledge of Allegiance, followed by a moment of silence. Reference was made to open meeting laws, posted at the entrance of the room. The agenda was approved upon motion of Commissioner Klingman, second of Commissioner Timm; Fischer, aye, Klingman, aye, Timm, aye. The minutes of the March 5, 2024, meeting was approved upon motion of Commissioner Timm, second Commissioner Klingman. Fischer, aye, Timm, aye, Klingman, aye.

Public comment. None.

No business for the Board of Equalization.

Next Link Internet presentation on broadband development in Deuel County was rescheduled for April 16<sup>th</sup>.

County Attorney Stellar shared information on the public rifle shooting range. NIRMA (the insurance company for the County) was not aware of another county within Nebraska that had a public shooting range. Sheriff DeCoste called the surrounding counties and none of them have shooting ranges open to the public. Stellar explained sovereign immunity and unfortunately, recreational shooting does not fall within those categories. Since Deuel County has received notice of a potential issue, the statutes that shield government entities from lawsuits are not in play. The liability exposure in this matter could be more than the five-million-dollar liability coverage that is provided by the insurance company. After a brief discussion, a motion was made by Commissioner Timm, seconded by Commissioner Klingman to close the rifle range at the Deuel County Fairgrounds. Fischer, aye, Klingman, aye, Timm, aye.

Assessor Bartlett presented the Cardinal Assessment Group Appraisal Contract for 2024-2025. A motion by Commissioner Timm, seconded by Commissioner Klingman to approve the contract as presented. Timm, aye, Fischer, aye, Klingman, aye.

Assessor Bartlett presented the GIS Layers contracts. A motion by Commissioner Timm, seconded by Commissioner Klingman to approve the contract as presented. Fischer, aye, Klingman, aye, Timm, aye.

The Deuel County Planning Board is recommending implementing new building permit fees and increasing penalties for not applying for a permit. The current charge for a building permit is \$25.00. Planning & Zoning Administrator Bartlett will suggest changes to the Planning & Zoning Board and present the information at the next meeting.

At 9:30 a.m. the Board took a short recess. At 9:34 a.m. the meeting resumed.

Stellar and Sherman presented information on providing family health insurance benefits to all employees of the county. After a discussion, a motion was made by Commissioner Klingman, seconded by Commissioner Timm to move forward with putting the benefits in place for the July 1, 2024, health insurance renewal date. Fischer, aye, Klingman, aye, Timm, aye. Stellar and Sherman will work on resolutions for review and approval at future meetings detailing the changes.

Highway Superintendent Krajewski updated the Board on the operations in the roads department. Krajewski will present bids for the repair work that is needed on Wheatland and Road 167 at the next meeting. Fusilier addressed the Board stating that he will be taking the Highway Superintendent's test on April 5<sup>th</sup>. Fusilier stated that it will take two years of working with a licensed Highway Superintendent before he will have his class A license. He will be working with Kopetzky and Krajewski on the office duties for the highway department.

Sheriff DeCoste presented the February fee report. Total fees collected \$5,975.40. DeCoste presented Sheriff Deputy Sean Holloway with a five-year service plaque. DeCoste stated that Holloway has been a valuable employee of the department and his work within the department is appreciated.

A motion by Commissioner Fischer, seconded by Commissioner Klingman to enter executive session at 10:09 a.m. with the following present: Fischer, Klingman, Timm, DeCoste. At 10:48 a.m. a motion by Commissioner Fischer, seconded by Commissioner Klingman to adjourn the executive session. Timm, aye, Klingman, aye, Fischer, aye.
