Reference was made to open meeting laws, posted at the entrance of the room. No business for the Board of Equalization.

Meridith Toyne, on behalf of the 4-H youth participating in the shooting program, addressed the Board concerning the closing of the rifle range. The 4-H shooters only practice with a licensed instructor present/on-site. The program promotes safety for firearms usage for the 4-H participants. The program runs from May through fair. The Commissioners appreciated the information and the work that is being done with the area youth. County Attorney Steller offered suggestions for Toyne to investigate regarding the possibility of 4-H shooting at the rifle range. At this time, the range will stay closed. The Sheriff's department and the Roads department will make sure the fencing and signs are in place.

Paul Strommen of Sidney, NE introduced himself as a candidate for Legislature District 47.

Elaine R. Menzel with the Nebraska Association of County Officials updated the Board on the goings on with the association and the Nebraska Legislature.

Sheriff DeCoste presented a bid from Anderson Auto Group who holds the state bid for patrol vehicles. The bid for a 2024 Ford PUV AWD fully equipped is \$50,388. The Commissioners agreed that a new vehicle does need to be ordered for the Sheriff's department, per the bid presented by DeCoste. One of the current pickups being used by the Sheriff's department will be transferred to the Road Department.

Sheriff DeCoste presented the March fee report. Total fees collected were \$357.20. DeCoste introduced Sydney Rushman, the new School Resource Officer.

Commissioner Klingman presented the Proclamation of May as Mental Health Month from the Region 1 Behavioral Health Authority. The proclamation is in support to create awareness and understanding for mental illness in the panhandle.
